Training in the curative veterinary practice or in an animal hospital

Art. 57 Training Schools, Duration

- (1) The first section of the training, which can be fulfilled in the curative veterinary practice or in an animal hospital or divided equally in two facilities, lasts 150 hours within at least four weeks, which should follow one another. It may not be fulfilled before passing the Veterinarian Preliminary Test.
- (2) The second section of the training, which can be fulfilled in the curative veterinary practice or in an animal hospital or in a combination of not more than four of these facilities, lasts 700 hours irrespective of Art. 60 and can be fulfilled according to the specifications of the study regulations of the university within at least 16 weeks, which should follow one another.
- (3) The acquisition of the certificate of a regular and successful participation in the educational presentations specified for the radiology subject examination is requisite for the beginning of the training according to paragraph 2.

Art. 58

Training in the curative veterinary practice

- (1) The training in the curative veterinary practice may only be fulfilled with veterinarians, who
- 1. independently carry on a practice for at least two years,
- 2. operate a veterinarian pharmacy and
- 3. have not been penalized under the law regulating the profession in the two years before the beginning of the training.
- (2) During the practical training according to Art. 57 the students have to play a part under the supervision, direction, and responsibility of the owner of the practice in all areas of the relevant veterinary field of activity.
- (3) The students obtain a certificate of the training according to Appendices 8 and 9.

Art. 59

Training in the animal hospital

- (1) The training is to be fulfilled in the hospital of a university. It can also be fulfilled in other hospitals under veterinarian direction, which are recognized as an animal hospital by the responsible veterinary chamber
- (2) During the training according to paragraph 1 the students have to play a part under the supervision, direction, and responsibility of the management of the hospital in the area of work of the relevant animal hospital. In the process they are to continue in the theoretical-scientific development of the fields of knowledge, which are affected by the practical training.
- (3) The students obtain a certificate of the training according to Appendix 10.
